IMPORTANT INSTALLATION INFORMATION

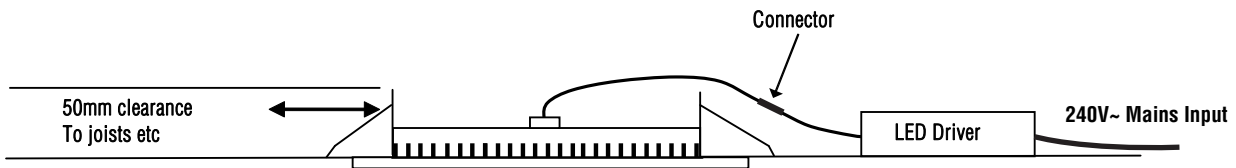
- Installation should be carried out in accordance with the latest edition of the National wiring regulations (For Australia please check the latest edition of the Wiring Rules -AS/NZS 3000:2007). If in doubt please consult a qualified electrician.
- For indoor use only.
- Dimmable driver sold separately.
- Dimmable range: Dimmable from 100 - 20% with most leading or trailing edge dimmers.

INSTALLATION INSTRUCTIONS

1. Before commencing installation or maintenance, ensure electricity is switched off at the mains.
2. Select the required position for the luminaire ensuring the clearances shown in the diagram are observed. Beware of joists, water pipes and electric cables.
3. Cutout details:
 - EN-PL06B = 107mm Ø
 - EN-PL09B = 133mm Ø
 - EN-PL12B = 157mm Ø
 - EN-PL18B = 206mm Ø
 - EN-PL24B = 280mm Ø
4. Connect the LED Driver to the mains supply, using a suitable junction box;
 - Brown – Live
 - Blue – Neutral
5. The LED driver is connected to the downlight by a jack plug/socket connector.
6. This luminaire is Class 3 and ensure that it does not come into contact with any earthed metal.
7. Push the LED driver through the cut-out and into the ceiling void and away from the luminaire.
8. Slide the legs of the mounting spring clips into the ceiling cut-out and push the luminaire up into the aperture. Ensure that it is securely located.
9. Switch on the power supply.
